About RTI Act 2005

The **Right to Information Act, 2005 (No. 22 of 2005)** was enacted by the Parliament and enforced from **June 15, 2005**. The Act provides for the *Right to Information* for citizens to secure access to information under the control of public authorities, in order to promote **transparency and accountability** in the functioning of every public authority.

According to the **UGC Guidelines**, all universities and colleges:

- Established by law made by Parliament or State Legislature.
- Notified by the appropriate Government, or
- Owned, controlled, or substantially financed (directly or indirectly) by funds provided by the Government.

shall come within the purview of a **Public Authority** under the RTI Act.

RTI Application Process:

- Any citizen may request information from the college by submitting a written application under the RTI Act, 2005.
- The prescribed fee of ₹10/- (by Indian Postal Order/Demand Draft/Cash) should be paid in the name of *Principal, Madhukarrao Pandav College of Engineering, Bhilewada, Bhandara.*
- The **CPIO** shall provide information within **30 days** of receipt of the application (or within **48 hours** in matters concerning life and liberty).
- In case of dissatisfaction with the response of the CPIO, the applicant may appeal to the **First Appellate Authority** within **30 days**.
